Modifications vs. Accommodations:

- <u>Modifications</u> Alters the curriculum and expectations of the student to allow them to achieve (e.g., alternate books, reworded questions, etc)
- <u>Accommodations</u> Additional supports allowed to help a student reach the general education benchmarks (e.g., using a calculator, extended time)

SPED vs. Related Services:

- <u>SPED Services</u> Specially designed instruction to increase a student's chance to succeed in accessing the curriculum.
- <u>Related Services</u> Services that supplement or support a student's education and core instruction to help them be successful.

Placement: Where a student is receiving educational services. Often discussed as the percentage of time spent in the general education classroom.

Transition Services: Refers to the transition out of high school and into adult life. Considerations for transition services begin at the age of 16 in most states.
